### **PROFIT WARNING SUPPLEMENTARY ANNOUNCEMENT**

This announcement is made by Elate Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Further to the profit warning announcement of the Company dated 23 March 2020, the board of directors (the “**Board**”) of the Company wishes to further inform shareholders of the Company and potential investors of the Company that having assessed the currently available information, the Group is likely to record a consolidated loss attributable to owners of the Company from the continuing operations over US\$7.0 million for the year ended 31 December 2019 which was mainly attributable to the impairment of investment on film rights amounted to approximately US\$4.0 million, as compared to a consolidated loss attributed to owners of the Company from the continuing operations of approximately US\$1.1 million for the year ended 31 December 2018 (the consolidated profit attributed to owners of the Company from both continuing operations and discontinued operations of approximately US\$6.909 million) .

The Company is still in the process of finalising the financial results of the Group for the year ended 31 December 2019. The information contained in this announcement is only based on the preliminary review and analysis of the Group’s latest unaudited management accounts and the information currently available to the Board, and have not been audited or reviewed by the Company’s auditors. The audited annual results announcement of the Group for the year ended 31 December 2019 is expected to be released on 30 March 2020.

**Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.**
